1. Eligibility Criteria:

- a. Bidder must be registered as a Recycler / Reprocessor / Dismantler / Collection / Storage of e-Waste with Central Pollution Control Board under Sub-section(1) of section 3 of the Water (Prevention and Control of Pollution) Act, 1974 (6 of 1974), Ministry of Environment and Forest, Government of India or with the State Pollution Control Board or State Governments dealing with E-waste, etc.
- b. Bidder must not be blacklisted by any Department of the Government of India or of any State / or by any PSU / Autonomous Organisation of Government. An undertaking regarding non-blacklisting of the bidder by any Government Organisation must be furnished by the bidder (**Annexure-A**).
- c. Bidder should be registered with GST/Service Tax / VAT with Departments of Government of India/State Governments.

2. Inspection of Items:

The inspection of material can be done carefully by the prospective bidders or by their representatives (A copy of such authority should be enclosed along with the bid) at Sardar Swaran Singh National Institute of Bio-Energy, 12 Km. No further clarification shall be entertained after the inspection.

3. Earnest Money Deposit (EMD) / Bid Security:

EMD will be submitted @2% of Base Amount in the form of DD in favour of "Sardar Swaran Singh National Institute of Bioenergy" payable at Kapurthala till 30/10/2023 at 11:00 am.

Minimum Reserved Price:

- a) The successful bidder will have to pay the entire quoted/offered amount within two working days either in cash or in the form of Bank Draft / Pay Order drawn in favour of "Sardar Swaran Singh National Institute of Bio-Energy" payable at Kapurthala, failing which the bid may be cancelled.
- b) Any taxes is leviable shall be paid by the successful bidder.

5. Lifting of e-waste / other items:

- a) Bidder shall file annual returns in Form 3 regarding the Waste Battery collected and recycled or refurbished towards fulfilling obligations under Extended Producer Responsibility with the Central Pollution Control Board and concerned State Pollution Control Board in Form 3 by 30th June of the next financial year. The details of the registered recyclers from whom the Extended Producer Responsibility certificates have been procured shall also be submitted with Institute.
- b) The successful bidder shall be required to lift all e-waste old / obsolete / unserviceable items and not selectively from the designated place to their premises on "AS IS WHERE IS BASIS", "WHATEVER THERE IS" and "NO COMPLAINT" basis will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quantity of the articles/items proposed to be auctioned within two working days after depositing full amount.
- c) In case, the successful bidder deposits the full amount within a stipulated period but fails to lift the articles in the scheduled time, this Institute shall not take responsibility for safe custody of articles.
- d) No damage shall be caused to the existing property of this Institute or any other Institute's premises while removing the materials from the site. Any loss/ damage to the property of this Institute or any other Institutes premises or injury or personal accident suffered by any person due to negligence or action of the successful bidder and they will be indemnified.
- e) Goods/ materials will be removed under the supervision of designated Officer(s) / Committee members of this Institute. Materials will have to be removed within the time stipulated in acceptance letter. No extension of time will be given under ordinary circumstances. Delay, beyond the stipulated time, may entail cancellation of the award/order.
- f) All the charges i.e. loading, unloading and transportation incurred in course of lifting of items from the designated place shall be borne by the successful bidder.

The successful bidder shall submit an undertaking (Annexure-B) that e-waste items out of old/ obsolete / unserviceable items, etc. will be stored / process / disposed off as per Rule 12 of Chapter IV of e-Waste (Management and Handling) Rules, 2011.

7. Other Terms and Conditions:

- a) Bid should be signed by bidder(s) himself/themselves or a person duly authorized in his behalf.
- b) The successful bidder will not be entitled to resell any of the articles/items while they are still lying within the premises of this institute and no delivery would be affected by this Institute to any person or person(s) other than the bidder whose name/names are mentioned in the Order.
- c) The bidder shall provide complete details in the format enclosed along with this document.
- d) In the event of failure of the successful bidder to lift the items in the stipulated time frame, legal action may also be initiated. Further, the bidder will be blacklisted for further business with this Institute and the Contract will be awarded to next Highest Bidder to lift the item(s) at H1 rate(s).
- e) The bidder should also provide the self-attested copy of the valid registration certificate issued by the Central Pollution Control Board or the State Pollution Control Committee along with the tender document failing which the tender will be rejected. The successful bidder shall produce the original certificate before lifting of the items from said location.
- f) No bidder will be allowed to withdraw the bid after completion of bidding process.
- g) The bidder who has quoted maximum price, subject to the condition that it should be more than the reserve/base price fixed by the committee, shall be considered as successful bidder.
- h) Institute employees and their families are not eligible to participate in the auction bid.
- i) The auction shall be subject to the Indian Laws and jurisdiction of the Courts located in Kapurthala.
- j) If a firm violates any of these terms & conditions, the same shall be blacklisted and other legal action may be initiated.
